Opportunity for First Time Homebuyers

First Front Door Program - Starting April 16

- By contributing a minimum of \$1,500 toward down payment and closing costs, homebuyers are now eligible for a maximum FFD grant of **\$15,000!**
- Must be a first time homebuyer.
- Household income of no more than 80% of your county's median household income.
