#### <u>Limited Liability Company (LLC)</u>

- LLC Operating Agreement
- Articles of Organization
- Paperwork for EIN/TIN number
- Valid photo ID and current address for owners and authorized signers

#### Club/Organization/Association

- Paperwork for the EIN/TIN number
- · Meeting minutes and list of officers
- Fictitious name agreement or certification of formation (if applicable)
- Valid photo ID and current address for owners/officers and authorized signers
